

Incorporation of STCPs into Schedule 2 of the STC

A STC Committee Paper

Overview

This paper recommends that the following STCPs be formally incorporated within Schedule 2 of the STC, effective Wednesday, 30th March 2005. In accordance with the agreement made at the STC Committee meeting of 19th March 2005, these STCPs will not be published upon the Code Website until 1st April 2005 or such point SP Transmission Ltd and Scottish-Hydro Electric Transmission Ltd have reviewed these STCPs for items of a confidential nature.

The change that has been made to STCP 12-1 is the addition of an Appendix which clarifies the STCPs and the versions thereof that have been included in the Data Catalogue within STCP 12-1.
