1 Introduction

1.1 Scope

- 1.1.1 This document defines the process associated with invoicing & payment activities between the TOs and NGET.
- 1.1.2 For the purposes of this document, the TOs are:
 - SPT; and
 - SHETL.

1.2 Objectives

- 1.2.1 The objective of this procedure is to detail:
 - how the invoicing and payment process is addressed across the NGET TO interface;
 - the requirements for exchange of information related to invoicing & payment activities; and
 - the lines of communication to be used.

1.3 Background

- 1.3.1 NGET shall be responsible for the calculation, development and invoicing of Connection and TNUoS charges. The TO shall be remunerated by NGET for the provision of connection and infrastructure assets and associated services.
- 1.3.2 The TO's revenue from NGET will be in three parts:
 - TO General System Charges as defined in Schedule Ten of the STC;
 - TO Site-Specific Charges as defined in Schedule Ten of the STC; and
 - Other Charges (ad-hoc activities) as defined in Schedule Ten of the STC.
- 1.3.3 NGET shall be remunerated by a TO for Other Charges (ad-hoc activities) as defined in Schedule Ten of the STC.
- 1.3.4 The majority of this revenue will be invoiced on a monthly basis (see sections 3.1 and 3.2), with the remainder on an ad-hoc basis (see section 3.3).

2 Key Definitions

2.1 For the purposes of STCP 13-1 Invoicing & Payment:

- 2.1.1 **NGET Revenue Contact** means the named contact within NGET for revenue issues as advised to the TOs from time to time.
- 2.1.2 **Other Charges** means those charges specified in Part Three of Schedule Ten.
- 2.1.3 **TO General System Charges** means those charges specified in Part One of Schedule Ten.
- 2.1.4 **TO Revenue Contact** means the named contact within the TO for revenue issues as advised to NGET and the other TO from time to time.

2.1.5 TO Site Specific Charges means those charges specified in Part Two of Schedule Ten.

3 Procedure

3.1 The Monthly payment of TO General System Charges

- 3.1.1 The TO shall receive payment from NGET each month for TO General System Charges. By 1 October -November each year the NGET Revenue Contact shall email the TO Revenue Contact requesting a forecast of their TO General System Charges for the following Financial Year. The TO Revenue Contact shall email the NGET Revenue Contact, on or before 1st November by 30 November each year, their forecast of the TO General System Charges for the following Financial Year.
- 3.1.2 The TO shall invoice NGET a twelfth of the amount forecast in 3.1.1 and NGET shall pay the recurrent monthly TO invoice on the later of
 - the 15th day following the day that the TO's invoice therefore was despatched; and
 - the 16th day of the month to which the invoiced payments relate,

unless, in such case, such payment day is not a Business Day in which case payment shall be made on the next Business Day.

- 3.1.3 Paper invoices will be despatched by post, and supported by fax and or email, where feasible, to the NGET Revenue Contact. The TO's bank account details shall be included with each monthly invoice.
- 3.1.4 All payments will be by BACS.

3.2 The Monthly Payment of TO Site-Specific Charges

- 3.2.1 The TO shall receive payment from NGET each month for TO Site-Specific Charges.
- 3.2.2 On or before the 1st November By the 30 November each year the TO Revenue Contact shall email the NGET Revenue Contact a schedule of the monthly TO Site-Specific Charges per site per customer, for each month of the following Financial Year.
- 3.2.3 The TO Revenue Contact shall give no less than 3 months prior written notice to the NGET Revenue Contact of any changes to the schedule provided in clause 3.2.2.
- 3.2.4 The TO shall invoice NGET each month the amounts contained in the schedule, and NGET shall pay shall pay on the later of
 - the 15th day following the day that the TO's invoice therefore was despatched; and
 - the 16th day of the month to which the invoiced payments relate,

unless, in such case, such payment day is not a Business Day in which case payment shall be made on the next Business Day.

3.2.5 Paper invoices will be despatched by post, and supported by fax and or email, where feasible, to the NGET Revenue Contact. The TO's bank account details shall be included with each monthly invoice.

3.2.6 All payments will be by BACS.

3.3 Payment for Ad-Hoc activities

- 3.3.1 Where a payment is required between NGET and the TO that is not included in the monthly billing process, this shall be invoiced on an ad-hoc basis. The invoice shall reference a purchase order number where appropriate.
- 3.3.2 Where the payment is required by the TO this will be in accordance with Other Charges in Schedule 10 of the STC.
- 3.3.3 All invoices for payments for Other Charges in Schedule 10 of the STC shall be despatched not less than 30 days prior to the due date for payment. Payment shall be made by the recipient of the invoice within 30 days of the date of the despatch, or within 30 days of the invoice date, whichever is the later.
- 3.3.4 Paper invoices will be despatched by post, and supported by fax and or email, where feasible, to the NGET or TO Revenue Contact, as appropriate. The bank account details of the Party receiving payment shall be included with each monthly invoice.
- 3.3.5 All payments will be by BACS.


3.4 Ancillary Payment Issues

3.4.1 All other payment related issues (e.g. addressing late payment by any party) shall be addressed in line with the STC.


