Discussion and Questions

Introduction by Phil to what will be discussed and the agenda.

1. Balancing costs monthly update - Filippos

Phil went through an opening benchmark slide and explained the benchmark dropped and the actuals fell in line. Explaining the two factors used for the new benchmarks are wind and wholesale prices over the last three years and the relationship that they've had with actions over the last three years. Phil then passed over to Filippos.

May balancing costs: Filippos Panagiotopoulos talked through drivers of the month's balancing costs.

James: Do you have a view of the constraints and non-constraints costs compared with the benchmark? Phil: We do have that information and can send across after this meeting.

2. Balancing costs engagement update - Lizzie

Lizzie gave an update on some of the engagement activity that's been going on. Lizzie has had a recent conversation with senior leaders, Grendon and Eleanor. Grendon shared with us a list of potential projects that he would like us to work on and we're not working on. A key highlight taken away was bringing designers into the conversation about these ongoing and future projects. There was also talk of a potential follow on workshop whereby we go through that strategy in more detail. The two things that I understood from Eleanor's comments were firstly; key is the proportion of savings. Secondly, is to just make sure that we're all on the same page in terms of the projections. Designers have been doing a fair bit of work with our networks team on long term significant policy changes around onshore wind locations and new nuclear builds. These could be hugely influential on balancing costs 2030 onwards. So the question for Ofgem is where should the focus be going forward with this list of projects? Should it be, all the things that that are in the pipeline and that are outlined in our strategy or do we want to focus more on the future? Lizzie believes it is a bit of both.

There is a whole list, which has been broken down from the strategy into sort of more granular parts. Hopefully, against each part we can be specific to saying what is going on in this space. Lizzie asked Ofgem, which would you like to hear more about? Ofgem happy to receive the list and look.

ACTION: Lizzie is going to send the list to Ofgem who will rank each part out of 10. With 10 meaning, I'd like to know more and 1 being, I'm not interested.

Lizzie mentioned they are also working on our external strategy as well and will keep Ofgem in the loop on this as it develops.
