Key areas of discussion

The aim of Workgroup 8 was to review and agree on the modification solution, terms of reference, legal text, Workgroup Report and for the Workgroup Members to cast their vote.

Review of Actions log

The Workgroup agreed to close all outstanding actions.

Review of Terms of Reference and Timeline

The Chair shared with the Workgroup the Terms of Reference for reviewing and it was agreed that all have been completed.

The Chair shared the current Timeline with the Workgroup, and the Proposer pointed out the 5 days between the Panel meeting and the CAC being issued, and asked if it was possible to shorten those in order to meet the October Panel for the CAC submission, instead of the November one. The Chair will speak with the Panel secretary on this.

Final Review of Solution Map and Draft Legal text

The Workgroup reviewed the final Solution Map and the Chair asked about the possible requirement for a new/amended STCP to be raised separate to this modification. The Proposer and ESO representative agreed that the STCP only be introduced if there was a need for it and felt that, as per the Proposer comments in the last meeting, the solution provided by this modification to the STC does not warrant STCP changes at this time.

The Proposer advised that an area where an STCP might be useful in the future is around the intervention process and the coordination needed for that process, but that it can be considered if CM079 is approved. The Workgroup agreed.

ESO

The Proposer noted that in the Solution Map the Delivery of Assets and Works is marked as red in the Change RAG status and explained that this is due to the fact that this STC modification has done as much as it can to avoid any disparities between the proposed CUSC solution, but that there are some aspects that the STC can't govern.

The Ofgem representative advised that after conversation with colleagues the plan is to consider this modification together with the CUSC modifications as a package to make an overall decision (which aligned with the Workgroup's expectations).

The Workgroup reviewed the final Legal Text and agreed on the final changes.

Final Review of Workgroup Report

The Chair shared the Workgroup Report with the Workgroup and explained the minor adjustments made to the document which the Workgroup had received to review ahead of the Workgroup.

The Proposer noted that, for transparency, clarifying statements relating to one particular Workgroup Consultation response should be referenced in the Workgroup Report as having been received post consultation (as it was requested by the Chair on behalf of the Workgroup to add context to the respondent's original submission). The Workgroup agreed and the Chair will make the required alterations and circulate the updated Workgroup Report to the members.

Workgroup Vote

The Workgroup Members voted, with all 5 voters saying that the Original Solution was better than the Baseline.

It was noted that all Workgroup members, apart from the ESO representative, advised that they believe that CM079 solution rectifies the changes required in the STC if the CUSC modifications are approved. However these Workgroup members stated that there were still concerns and underlaying issues around the proposed CUSC modifications, explaining the negative assessment to the STC objectives.

- The Chair to share the updated Workgroup Report with the Workgroup.
- Workgroup Report to be submitted to Panel on the 14th of September.
