

Solution:

 The Proposer has suggested minor changes to the SQSS through the introduction of an Appendix I which specifically addresses the requirements for System Restoration. These changes compliment other changes being introduced to the Grid Code and STC.

Code Administrator Consultation Responses

Summary of Code Administrator Consultation Responses :

- Code Administrator Consultation was run from 31/07/2023 to 29/08/2023 and received 1 non-confidential responses and 0 confidential responses. Key points were:
 - The response was from the Proposer, who believes that the solution better facilitates all of the SQSS applicable objectives.
 - Respondent felt that GSR032 will align the SQSS to the proposed changes to the System Operator Transmission Owner Code (being implemented through CM089/CM091 and PM0128/PM0132) and proposed changes to the Grid Code (being implemented through GC0156).
 - No legal text issues identified.
