Key areas of discussion

The aim of Workgroup 5 was to assess Workgroup Consultation response, Review the Draft Workgroup Report, and Review Proposed DOC6 Legal Text.

Objectives, Actions Update, Timeline

The Chair outlined the objectives for the meeting. The Chair proposed closing all the actions, which the Workgroup agreed with.

Review Workgroup Consultation Responses

The Chair presented the summary of the Workgroup Consultation responses, which can be viewed in the GC0162 Workgroup papers on the ESO website.

A Workgroup member asked the Ofgem representative if there were any other 'scenarios' the Authority would like the Workgroup to consider and asked that they confirm this prior to Workgroup 6 (Action 21).

Draft Legal Text

Minor amendments to the legal text in OC6.1.5 and OC6.5.5, as suggested as part of a Workgroup Consultation response, were agreed by the Workgroup. The Proposer agreed to amend the legal text in OC6.1.5 and OC6.5.5 (Action 22).

Review Draft Workgroup Report

The Chair presented the Draft Workgroup Report. Amendments to the interactions section, what is the issue section, legal text section, Workgroup consultation summary section, and Workgroup considerations section were accepted by the Workgroup, with some very minor alterations.

ESO

An ESO representative explained how the text 'separate instructions in sequence' from the Company to the DNOs would work in practice. 'Separated by several minutes' was added to the text in the Workgroup considerations section of the Workgroup report, to make it clear that the instructions are separate.

The Workgroup discussed how The Company and DNOs could communicate on the expected timeframes for DNOs to enact Demand reduction. It was agreed that this communication should happen in advance of events, and an ESO representative agreed to discuss this further with DNOs.

The Workgroup discussed the drafting of a new section in the Workgroup report that reflected a scenario where 'Demand Control under OC6.5 was instructed, and during that enaction, another event on the system triggered LFDD'. It was agreed to amend the reference to specifically 5% to 'additional percentage', to be less specific. It was agreed by the Workgroup to review this section of text further offline, ahead of the next Workgroup.

Review Proposed DOC6 Legal Text

The Workgroup reviewed the proposed DOC6 Legal Text and confirmed that the document will be consulted on in the coming weeks. There were no comments made by the Workgroup. Given the consultation is in a few weeks, the Workgroup was made aware that they have time to comment on the document offline.

AOB

The Chair confirmed that GC0161 has been approved and will be implemented on 02 October 2023. The corresponding changes to the Distribution Code were effective from 15 September 2023.

Next Steps

The chair summarised the next steps as follows:

- Draft Workgroup Report to be shared with the Workgroup for comments before the next Workgroup.
- Next Workgroup is on 03 October 2023 where the Workgroup Vote will be completed.
