# Scope of sub-group - as agreed at CUSC Panel

Taken from ToR, the scope of the sub-group is as follows:

- Provide clarity on the horizon of strategic connection change.
- Signposting to more medium-term change such as Connections Reform.
- Focusing immediate discussion on connections five-point plan initiatives including the ESO's new policy for battery storage connections.
- Breaking down the ESO's line of thinking regards to implementation of these initiatives and addressing concerns raised by stakeholders both in terms of governance and post implementation impacts.
- Provide opportunity to deep dive on those change initiatives of interest. This will ensure the industry can understand how this change will manifest and work in practice or understand the current remit of ESO exploratory work
- Aim is therefore to help identify any CUSC code governance gaps or downstream impacts and ensure these gaps or impacts are addressed appropriately and stakeholder are engaged on this journey.

Our 5-Point Plan is a set of Tactical Initiatives ahead of the wider connections reform

- 1. TEC Amnesty
- 2. Construction Planning Assumptions Review
- 3. Treatment of Storage
- 4. Queue Management
- 5. Non-firm Offer Development



# **Connections** Reform

#### **Consultation Phase up to and including Final Recommendations**

- Delivery Partners Executive Group (DPEG)
  - Help inform and support efficient delivery of changes to the connections process.
  - Propose and agree practical and deliverable actions necessary to support the implementation of connections reform.
- Steering Group
  - Ensure our key stakeholders and consumers have a formal voice as we developed options for connections reform.

#### Implementation Phase (from January 2024). Proposed governance structure is:

- Connections Delivery Board (CDB)
  - Replaces DPEG.
  - Expected to be run by Ofgem or DESNZ.
  - Sets overall direction and provides steer for connections initiatives, as well as holding organisations to account for delivery of changes.
- Connections Process Advisory Group (CPAG)
  - Replaces Steering Group.
  - Independent Chair and representatives from all impacted parties.
  - Provide steer on all parts of Connections Reform implementation and helps coordinate the suite of changes that need to be made across codes (prior to formal code Modifications being raised).

Making final recommendations in next few weeks and expect to run in person event and webinar shortly thereafter to run through final recommendations.

Implementation phase to start from January 2024.
