Key areas of discussion

Legal Text

The Proposer presented a summary of the latest changes to Section D and J of the STC. The Proposer explained that the amendments made to 2.9 and its subparagraphs was to restrict reference to interface configurations to only the 2 most generic and allow for the different configurations in selection in TO's transmission areas and allow for the tender process to capture the instructions between CATO's and TOs.

The Chair shared the terms of reference and asked the Proposer to insert the location of where terms of reference have been met in the Workgroup Report.

Workgroup Report

The Chair presented the Workgroup Report to the Workgroup and advised what had been updated since the previous Workgroup meeting. These changes included the implementation date, due to the delay in publishing of enabling legislation.
