Approval of Panel Minutes

New Modifications

The following Modification Proposal was presented to the Panel:

<u>CM093 - Extending the principles of the User Commitment Methodology to Final Sums Methodology as a</u> <u>consequence of CUSC Modification – CMP417</u>

This modification seeks to deliver the required changes to the STC as a consequence of CMP417 which proposes to extend some of the principles of CUSC section 15 "User Commitment Methodology" to Users on Final Sum methodology.

The Panel unanimously agreed that CM093 should follow the Standard governance route and proceed to Workgroup. Term of Reference are to be updated with an additional objective and shared with Members.

Ofgem provided an update on Modifications that are currently awaiting their decision since the last STC Panel.

Awaiting Decisions

Modification	What this seeks to achieve	Expected Decision Date
CM080 Transmission Impact Assessment process	Process for aggregated assessment of Distributed Generators that impact (or may impact) on the National Electricity Transmission System.	Relates to CMP298, expected decision date of 30 November 2023 will not be achieved. Ofgem have indicated a date on 14 December 2023.
CM089/CM091 Emergency and Restoration Code Phase II	Clarify the requirements on STC parties in order to implement the requirements of the EU Emergency and Restoration Code.	Relates to GC0156/GC0148, expected decision date of 30 January 2024.

Ofgem publish a table that provides the expected decision date, or date they intend to publish an impact assessment or consultation, for code modifications/proposals that are with them for decision. This was last updated on 14 November 2023 and is published here.

Draft Final Modification Reports

The following Draft Final Modification Report was presented to the Panel:

CM079 - Consideration of STC/STCP changes in relation to CMP330/374

This modification will consider the proposals being discussed in CMP330/374 and CMP414 for how these might lead to STC or STC Procedures to ensure any consequential changes are proportionate.

The Panel has recommended unanimously that the original solution better facilitates the STC Applicable Objectives.

The Final Modification Report will be issued to Panel members on 1 December 2023 for five working days to check their votes. The Final Modification Report will be issued to Ofgem on 11 December 2023.
