Key areas of discussion

The Chair led the introductions and outlined the objectives of the meeting.

Objectives and Timeline

The CFhair shared the timeline and the intention to hold the Workgroup Vote at the next Workgroup. All Workgroup members confirmed availability to attend this meeting.

Review of Draft Workgroup Report

The Chair shared minor amends received from one Workgroup member had been made to the Report.

The Chair took Action 29 to update the Consumer impact section of the Workgroup Report with details supplied by a Workgroup member and the ESO revenue team when supplied (Action 27).

A Workgroup observer shared that as OFTO's we had understanding that STC Section K is in place to ensure that the OFTO Transmission System can satisfy the various power quality elements, but the ESO is saying that it's there to provide wider system benefits. The Workgroup observer suggested that a consequential change to Section K of the STC is required to clarify that point. A Workgroup observer stated that the premise on which CMP418 is based is that DRCE has wider system benefits beyond the OFTO connection point, but STC Section K states clearly that DRCE is only there for the OFTO network and to ensure the OFTO's maintain their networks. The ESO Representative explained that this is being considered in CM085 and therefore falls outside the scope of this modification.

The Chair suggested that this concern be included in the 'Cross Code Impacts' section of the Workgroup report with the recommendation that Section K of the STC requires revising. A Workgroup member stated that CMP418 is dealing with the defect in the proposal and that the Workgroup do not need to be concerned with the issue raised. The member went on to say it is just a recommendation that wording is changed in the STC and not sure it's an

obligation on the OFTO as the ESO purchases balancing services from DRCE and uses it for wider benefits, it's an obligation on OFTO's in terms as to what they have to do.

The Workgroup agreed that the STC should not say something different because of CMP418, but STC Section K requires a slight change to clarify what already happens. The ESO Representative reminded the Workgroup that this point regarding Section K of the STC is covered in CM085. The Chair took Action 30 to add this discussion into the Workgroup Report.

Confirm Solution

The Proposer confirmed that there are no changes to the solution and the Chair shared that no changes had been suggested by any Workgroup member.

The Chair led the Workgroup through a review of the Action log.
