Review of Workgroup Consultation responses

- The Workgroup reviewed the summary of the Workgroup Consultation responses in the draft Workgroup Report. Notes were added to certain responses for the Chair and Tech Sec to address where further clarity was needed.
- Notes were added to the Workgroup Report for points of note from the Workgroup (e.g. clarification of validity period, the treatment of modification applications by this/other modifications, stating all relevant users to which LoAs apply, treatment of demand applications, when a subsequent development modification may be raised)

Alternative requests

- An alternative request was discussed by the group which related to i) lower thresholds of
 minimum acreage and ii) inclusion of electrical connection points within the area for the LoA.
 The Proposer agreed to consider whether learnings (related to the acreage point) could be
 applied to the Original before an alternative vote was cast. The connection point aspect would
 need discussion at Workgroup 6.
- An alternative request was discussed by the group relating to an exemption approach and was voted to become WACM1.
- An alternative request was discussed by the group relating to an 'enduring' validity period for the LoA. Following discussion amongst the Workgroup, the proposing Workgroup member agreed to consider whether to continue with the alternative request.

Review of the draft LoA, review of the legal text and review of the ToR were postponed to the next meeting when the Proposer will have more updates to share.

There were no 'AOB' points raised by the Workgroup.
