# 1 Executive Summary

- 1.1 Following the establishment of STC working group, for the STC Amendment Proposal CA039, the STC Committee recognised that working groups within the Evaluation Phase as laid out in Section B of the STC was not very clear in its aim and usage.
- 1.2 The STC already enables the STC Committee to determine that additional information is required in order to assess whether a Proposed Amendment or any Alternative Amendment better facilities the Applicable STC Objectives and refer the Amendments to the Evaluations Phase where a working group can be established. National Grid has considered how working groups operate within other electricity codes and proposes a number of changes to Section B of the STC to provide some additional clarity and governance in relation to working groups.
- 1.3 As Proposer, National Grid supports the implementation of CA043 as it better facilitates the Applicable STC objectives, as appropriate working group arrangements are likely to lead to a more efficient administration of the STC in respect of the development and implementation of Amendment Proposals.
- 1.4 At the STC Committee meeting on 26<sup>th</sup> June 2011, the Committee agreed that CA043 should proceed directly to the Assessment and Report Phase.
- 1.5 Following Committee approval the Stage 2 Proposed Amendment Report was issued inviting representations by the 30<sup>th</sup> September 2011. One response was received and a copy of the representation is included in Annex 3.

#### **STC Committee Recommendation**

- 1.6 The STC Committee provisionally recommends that STC Amendment Proposal CA043 be approved for implementation.
- 1.7 Should the Authority approve STC Proposed Amendment CA043, it is recommended that the STC be amended 5 business days after the Authority decision.

# 2 Description of Proposed Amendment and its Effects

- 2.1 This Proposed Amendment seeks to make a number of non-material changes to Section B of the STC to incorporate additional governance for working groups established within the Evaluation Phase.
- 2.2 National Grid proposes an amendment to the STC in order to incorporate the following:
  - (i) To aid consistency between all the major Codes, it is proposed that the current working group terminology be changed to Workgroup.
  - (ii) Any representatives of the Parties can attend the Workgroup meetings but it will only be quorate provided at least one representative from NGET, one representative from Onshore Transmission Owner and one representative from Offshore Transmission Owner are present. The Authority can attend as an observer.
  - (iii) A chair for the Workgroup shall be appointed by the Committee.
  - (iv) The Committee shall finalise terms of reference for each Workgroup within 10 Business Days of determining that a workgroup shall be established. These can be updated over the duration of the Workgroup and should cover:
    - Workgroups responsibilities:
    - Detail of the Amendment Proposal
    - Detail the work to be undertaken by the workgroup to enable the workgroup to prepare its report
    - Detail any other matters to be considered by the Workgroup
    - Specify if the Workgroup is to comment upon any legal text
    - The timetable for which the work of the Workgroup is to be completed
  - (v) The Workgroup will consider alternatives raised prior to the Amendment Proposal being referred to the assessment and report phase.
  - (vi) The Workgroup shall develop its own internal working procedures unless directed otherwise by the STC Committee.
  - (vii) A Workgroup Report will be submitted to the Committee responding to the matters detailed in the terms of reference and contain the workgroups assessment and recommendation. In the event that the Workgroup are unable to reach an agreement then this shall be reflected in the report.
  - (viii) The draft Workgroup Report must be circulated to workgroup members with 5 Business days for comment.
  - (ix) The Workgroup Report shall be submitted for discussion at the Committee meeting.
  - (x) The chair or another member of the Workgroup shall attend or by teleconference the next Committee meeting to present Workgroup findings.
  - (xi) The Committee shall consider whether to refer the Amendment Proposal back to the Workgroup for further analysis or proceed to assessment and report phase.
- 2.3 No Alternative Amendments to CA043 were submitted.
- 2.4 At the STC Committee meeting on 26<sup>th</sup> June 2011, the Committee agreed that CA043 should proceed directly to the Assessment and Report Phase.

## 3 Impacts & Assessment

#### 3.1 STC Parties' Assessments

#### 3.1.1 National Grid View:

National Grid is supportive of Proposed Amendment CA043, and has carried out an Assessment of the Proposed Amendment.

The implementation of CA043 would not have any physical impact on National Grid's Transmission system or require changes to the IS Systems. - 4.3 The STC Committee has reviewed whether Workgroup members should have voting rights stipulated within the STC. The Committee has concluded that the purpose of the Workgroup members is to assist the Committee in the evaluation of the Proposed Amendment and consider whether it better facilitates achievement of the Applicable STC objectives. Paragraph 7.2.4.A8 of the drafted legal text requires the Workgroup Report to document issues and views and any recommendations made by the Workgroup. In the event the Workgroup is unable to reach an agreement this should be reflected in the Workgroup Report.
- 4.4 The STC Committee has also reviewed the governance arrangements for Workgroups within the CUSC and has found that there is no concept of voting, however, voting arrangements tend to be documented within the CUSC Workgroups Terms of Reference.
- 4.5 The STC Committee view is that the role of the Workgroup is to discuss and determine whether the Proposed Amendment better facilitates the Applicable STC Objectives and therefore voting arrangements are not required.
- 4.6 The STC Committee's view is that a non-TO party is not required for a STC Workgroup to be quorum. This doesn't preclude a non-TO party participating in a Workgroup should the party feel they have the relevant expertise to assess the Proposed Amendment or submitting a representation in relation to the Proposed Amendment Report.

## Annex 2 - Draft Legal Text

The following amendments shall be made at Section B of the STC.

#### 7.2.4 Evaluation Phase

- 7.2.4.1 The Committee shall use its reasonable endeavours in order to ensure that the Evaluation Phase as set out in this sub-paragraph 7.2.4 shall take no longer than two months (or if a Workgroup is established 4 months) from its referral under sub-paragraph 7.2.3.2 up to the referral to the Assessment and Report Phase under sub-paragraph 7.2.4.4 unless otherwise agreed by the Authority.
- 7.2.4.2 Following referral of a Proposed Amendment or any Alternative Amendment pursuant to sub-paragraph 7.2.3.2, the Committee shall invite representations or commission such studies, working groups and other evaluation including through establishing a Workgroup as it deems appropriate in order that each Party is provided with sufficient information such that it can assess whether the Proposed Amendment or any Alternative Amendment would better facilitate achievement of the Applicable STC Objectives.
- 7.2.4.A1 Where the Committee deems it appropriate, it shall establish a Workgroup in accordance with sub-paragraph 7.2.4.2:
- 7.2.4.A2 A Workgroup shall comprise at least three (3) persons [(who may be Committee Members)] agreed by the Committee provided there shall always be at least one member representing NGET, one member representing Onshore Transmission Owners and one member representing Offshore Transmission Owner. A representative of the Authority may attend any meeting of a Workgroup as an observer and may speak at such meeting.
- 7.2.4.A3 In addition to the quorum in 7.2.4A2, the Committee shall appoint the chair of the Workgroup who will not be able to vote.
- 7.2.4.A4 The Workgroup shall be assisted by a secretary who shall be appointed by the Committee.
- 7.2.4.A5 The Committee shall determine the terms of reference of each Workgroup and may change those terms of reference from time to time as it sees fit.
- 7.2.4.A6 The terms of reference for a Workgroup must include provision in respect of the following matters:
  - (a) Detail the Workgroup's responsibilities for assisting the Committee [and each party] in the evaluation of the Proposed Amendment or any Alternative Amendment and consider whether it better facilitates achievement of the Applicable STC

Objectives and to provide additional information to the Committee:

- (b) Detail the Proposed Amendment and any Alternative Amendment
- (c) Detail the work to be undertaken by the Workgroup to assist the Committee [and each party] in the evaluation of the Proposed Amendment or any Alternative Amendment.
- (d) Specify any matters which the Workgroup should address in its report;
- (e) the timetable for the work to be done by the Workgroup;
- (f) Specify if the Workgroup is to comment upon any legal text.
- 7.2.4.A7 Unless otherwise determined by the Committee the Workgroup shall develop and adopt its own internal working procedures for the conduct of its business.
- 7.2.4.A8 A Workgroup Report will be submitted to the Committee responding to the matters detailed in the terms of reference and in accordance with the timetable set out in the terms of reference and will indicate the issues and views which arose in the Workgroup discussions and any recommendations made.
- 7.2.4.A9 If a Workgroup is unable to reach agreement on any such matter, the Workgroup Report must reflect the views of the members of the Workgroup.
- 7.2.4.A10 The Workgroup Report will be circulated in draft form to the Workgroup members for a period of not less than five (5) Business days for comment. Any unresolved comments made shall be reflected in the final Workgroup Report.
- 7.2.4.A11 The final Workgroup Report shall be submitted to the Committee Secretary not less than five (5) Business Days prior to the meeting of the Committee at which that Workgroup Report is to be discussed.
- 7.2.4.A13 The chairman or another member (nominated by the chairman) of the Workgroup shall attend or by way of teleconference the Committee meeting at which that Workgroup Report is to be discussed and may be invited to present the findings and /or answer the questions of Committee members. Other members of the Workgroup may also attend such Committee meeting.

- 7.2.4.3 Following receipt of any representations, study, working group report—Workgroup Report or other evaluation pursuant to subparagraph 7.2.4.2, the Committee shall consider whether the information provided is sufficient for each Party to form a view as to whether the Proposed Amendment or any Alternative Amendment better facilitate achievement of the Applicable STC Objectives and may invite such further representations, studies, working groups and other evaluation including sending matters back to the Workgroup as it deems appropriate until the Committee considers that the information provided is sufficient.
- 7.2.4.4 Following completion of this Evaluation Phase under this subparagraph 7.2.4, the Committee shall refer the Proposed Amendment or any Alternative Amendment directly to the Assessment and Report Phase under sub-paragraph 7.2.5.

#### 7.2.5 Assessment and Report Phase

7.2.5.2 Following referral to the Assessment and Report Phase under sub-paragraphs 7.2.3.3 or 7.2.4.4, the Committee together with the Proposer shall prepare an analysis and impact assessment (to the extent that such assessment has not already been provided as part of the Evaluation Phase or Workgroup Report) ("Assessment"). Such Assessment shall include to the extent reasonably practicable an assessment by the Committee and the Proposer of the likely effect of the Proposed Amendment and any Alternative Amendment on each Party's Transmission System and other systems including a description of any works necessary to implement the change and an estimate of the development, capital and operating costs associated with implementing the changes to the Code and Code Procedures in such manner as the Committee feels fit, provided that, so far as any such Assessment requires information which is not generally available concerning the National Electricity Transmission System, such Assessment shall be made on the basis of the Committee's and the Proposer's proper assessment (which the Committee and the Proposer shall make available for these purposes) of the impact of the Proposed Amendment or any Alternative Amendment on the National Electricity Transmission System. Such assessment, shall also include, where the impact is likely to be material, an assessment of the quantifiable impact of the Proposed Amendment or any Alternative Amendment on greenhouse gas emissions, to be conducted in accordance with such guidance (on the treatment of carbon costs and evaluation of the greenhouse gas emissions) as may be issued by the Authority from time to time.

EDF Energy welcomes the opportunity to comment on National Grid's consultation on CA043: Clarification of Working Groups within the Evaluation Phase Reactive. We support consistency across all of the major Codes and their application to enable the secure, economic and efficient operation of the electricity transmission system.

Overall EDF Energy supports the intent of the proposed changes to the STC which essentially seeks to provide some additional consistency and governance in relation to working groups established under the STC. However we do seek clarification in regards to specifically the voting rights of members and/or attendees of a given working group. We would suggest that all workgroup members be able to vote as in other code working groups such as the CUSC and the BSC. Membership and voting rights could place more responsibility on those involved and therefore ensure that the required level of active participation is achieved and maintained. On a practical level we support the membership of the working group being open to all code parties and allowing observers to attend for information purposes. For completeness, in terms of quoracy specifically, we would also suggest a non-TO presence being required.
