Key areas of discussion

Review of the action log

All actions were reviewed and updates can be viewed in the actions log below.

Review of Legal Text

- CUSC Section 2 The Proposer presented the draft legal text to the Workgroup, which was agreed subject to the following:
 - 2.13.1 clarification was added to note that the LoA must follow the templates provided in an annex of the CUSC. Workgroup members discussed further clarification of this however did not make further changes to the legal text.
 - 2.13.2 one Workgroup member queried when the guidance note would be changed and how stakeholders would be consulted. The Proposer agreed to cover this within the guidance note.
 - 2.13.3 this legal text was amended and agreed by the Workgroup. Note: this section of legal text is only for the purposes of Alternative Request 2.

Review of draft LoA

- The Proposer presented the draft LoA templates to the Workgroup, noting changes that had been made since it was last reviewed by the Workgroup.
- There were no comments from the Workgroup.

Review of Workgroup Report

• The Chair presented the updated Workgroup Report to the Workgroup; minor changes were agreed by the Workgroup.

Review of Terms of Reference

 The Workgroup reviewed the Terms of Reference and agreed that these have been met within the Workgroup Report, and that the Workgroup Vote can be completed once the legal text has been finalised.

Alternative Requests

- GP presented their Alternative Request to the Workgroup.
 - One Workgroup member noted that the Alternative Request adds complexity that may not be required for the purpose of the modification to be achieved.
 - Another Workgroup member noted that they believed elements of the Alternative Request may be outside the scope of the modification but could be considered at a later date.
 - A further Workgroup member noted the possibility of a discrepancy with how connections are treated in Scotland, in comparison to in England and Wales.
 - The Proposer of the Alternative Request modified their Proposal to reflect the feedback received.
 - One Workgroup member noted that some projects may still be feasible if the threshold was below 50%, and the Workgroup had a discussion regarding what the threshold should be.
 - The Proposer of the Alternative Request removed their intention to consider multiple land ownership as part of the Alternative Request, noting that it should be considered in a subsequent modification.
 - The Workgroup agreed by majority that Alternative Request 2 should become WACM2.
- JH then presented their Alternative Request to the Workgroup, noting that it covers elements of the Original, WACM1 and WACM2. JH advised that this Alternative Request would allow Ofgem to consider all options together for approval.
 - The Workgroup agreed by majority that Alternative Request 3 should become WACM3.
