Decisions since the last Panel

Modification	What this seeks to achieve	Decision
GC0156	In October 2021, BEIS issued a direction in accordance with Special Condition 2.2 of National Grid’s Electricity System Operator’s Transmission Licence implementing an Electricity System Restoration Standard (ESRS) which requires 60% of electricity demand to be restored within 24 hours in all regions and 100% of electricity demand to be restored within 5 days nationally. The ESO is proposing a number of changes to the Grid Code to facilitate this.	On 05 February 2024 the Authority approved the original solution. It will be implemented on 04 March 2024.

Modification	What this seeks to achieve	Expected Decision Date
GC0154	This modification seeks to codify ramping requirements for Interconnectors (ICs) into the Grid Code	15 March 2023
