# 1 Introductions/Apologies for Absence

2996. Apologies were received from Andy Hiorns (NGET), Lucy Hudson (NGET) and Audrey Ramsay (NGET).

### 2 Approval of Minutes from the last meeting

2997. The minutes from the last STC Modification Panel held on 25 September 2013 were approved and are to be uploaded to the NGET website.

#### 3 Review of Actions

2998. **Minute 2727:** LH informed the Panel that some of the other Codes hold photographs of their respective Panels on the NGET website. Panel to ensure any outstanding photographs are sent electronically to LH by next STC Modification Panel on 27 November 2013.

2999. **Minute 2824:** MD confirmed that the Network Access Policies (NAP) has been submitted to Ofgem and approval is likely in October 2013. MD confirmed that a meeting is taking place 25 October 2013 to finalise the NAP and once agreed it will be circulated to the Panel.

3000. **Minute 2922:** In respect of the issue relating to STCP18-1/performance of delivery of connection offers, JD confirmed that a meeting had taken place with NGET on 28 August 2013 which identified that amendments will need to be made and that a further meeting is being arranged for November with TOs to identify the proposed changes to STCP18-1.

# PA066 – STCP19-3 Clarification of Transmission System Boundary Point registration with Elexon

- 3014. TD confirmed that STCP19-3 is currently being finalised internally and it is expected that this will be submitted to the November 2013 STC Modification Panel.
- 3015. JD noted that there are a couple of considerations in relation to interim commissioning where there is no physical transmission works that could be added to STCP. TD agreed to discuss possible additions to STCP 19-3 with the proposer.

3016. Additionally it was noted that the STCP could be clearer on the interaction with Elexon during boundary point registration. TD agreed to raise this with the proposer.

# PM070 – Update STCP04-6 to add IEC60870-5-101 Communication Protocol

- 3017. TD confirmed that due to internal NGET personnel changes, the amendments to STCP04-6 are expected to be submitted to the November 2013 Modification Panel.
- 3018. Panel members noted that the proposed wording of STCP04-6 indicates that the IEC protocol will be the preferred protocol going forward but this is not the preferred protocol for SPT and SHET assets. It was queried whether the proposed STCP04-6 would prevent other communication protocols from being used and it should be made clearer in the STCP drafting. TD agreed to query this with the proposer.

# PM071 - PM073 - Code Governance Review Phase 2

3019. The Panel had no further comments on the Code Governance Review Phase 2 STCPs and it was agreed that, subject to Authority approval of the CGR2 Modifications, they be progressed to sign off. LH to coordinate signoff of STCPs following an authority decision.

# 14 European Developments

3022. TD confirmed that the ENTSO-E and ACER updates regarding the latest European developments had been circulated to the Panel by LH.

#### 15 Impact of Other Code Modifications

3023. **Minute 2443:** NGET agreed to circulate the Final Modification Report for Grid Code modification GC0037 'Offshore BMU Configurations' to the STC Modification Panel, following its publication. This will allow STC consideration of the findings. TD confirmed that a draft version of the Final Modification Report was being reviewed and following submission to the Authority for a decision, a copy will be circulated to the Panel.

3024. **Minute 2446:** ML informed STC Modification Panel members that a Continuous Voltage Control paper was circulated to the Grid Code Review Panel (GCRP) which was informative. NGET agreed to keep the Modification Panel updated on the progress of the issue to ensure consequential changes to the STC are considered. TD confirmed that a paper will be sent to the November 2013 GCRP and that a copy will be circulated to the panel for information.

3025. It was noted that CUSC Modification 219, 222, and 223 should be monitored to determine any possible STC impacts.

3026. A JPC meeting was held on 22 October 2013, the minutes of which will be circulated to the Panel once available.
