1. Title of Modification Proposal (mandatory field)

Code Governance Review (Phase 2): The Send Back Process

2. <u>Description of the Proposed Modification</u> (mandatory field)

This Modification proposal seeks to introduce into the STC one of the proposals highlighted in CGR (Phase 1), the Send Back process. National Grid propose to introduce the ability for the Authority to 'send back' a Modification Report in instances where we are unable to make a decision based on, for example, a technical flaw or deficiency in the analysis.

This Modification Proposal would enable the Authority to send back a Modification Report to the STC Modification Panel (the "Panel") in circumstances where the Authority considers that it is unable to form a decision based on the content of the Modification Report. It is judged that the 'send back' provisions will provide an effective safeguard against the Authority being placed in a position where it is unable to approve a modification owing to deficiencies in the report such as insufficient assessment, incorrect legal text or other technical issues. The Authority can then specify the action that it believes is required and the modification process would allow for corrective action to be taken.

The send back process provides flexibility to allow for any situation and for the Panel to remake a recommendation based upon work carried out.

3. <u>Description of Issue or Defect that Proposed Modification seeks to Address</u> (mandatory field)

The STCP at present does not have a process in place for The Send Back Process. This Modification proposals seeks to implement the Significant Code Review aspect of the Code Governance Review (Phase 2) proposals and meet the new requirements under the modified electricity transmission licence.
