Key areas of discussion

The aim of Workgroup 6 was to review the legal text and draft Workgroup Report.

Action Update

The Chair led a review of the action log and the Workgroup group agreed to close actions 9, 10, 11 and 12.

Legal Text Update

The Proposer informed the Workgroup that they had discussed the amendments offline with their legal team and made amendments for further clarity as suggested in the last Workgroup.

Key further discussions on the legal text were as follows:

- Definition of Central Strategic Network Plan: a Workgroup Member suggested an amendment to the wording to strip out any mention of future publications as once CMP428 is implemented into the CUSC, the wording would shortly be outdated. The Proposer agreed to further amend the definition.
- Excepted Works definition: the Workgroup suggested amendments to include reference to the HND document published in July 2022 and the Beyond 2030 report, which replaces tCSNP.
 - Workgroup members queried whether a guidance note would be produced with the Proposer responding that a guidance note is not designed to be updated regularly but is provided to help give an overview. Workgroup members disagreed but understood it would be the Proposer's prerogative.
- HND/OTNR definition: a Workgroup member suggested including the defined term OTNR within the HND definition to save the reader having to move up and down the definitions. The Proposer agreed to look into removing the OTNR definition and include it within another defined term.

Review Draft Workgroup Report

The Chair shared the Workgroup Report and went through the comments received offline. A Workgroup member suggested some rewording to give a cold reader more clarity on what the modification was trying to achieve. The Workgroup agreed to the changes save for amendments made to the Proposer's Assessment against the objectives section. The Chair reminded the Workgroup they would be able to give their assessment on the voting statement and this section was for the Proposer.

The Chair shared the timeline with the Workgroup and explained there would be one more Workgroup before sending the Workgroup Report to Panel. Workgroup members had no comments on the timeline.
