Key areas of discussion

The objectives of the fourth Workgroup were to review the Workgroup consultation responses and review the legal text update.

Workgroup Consultation Responses Review

Proposer update

The proposer shared the proposed legal text which makes changes to CUSC 14.15.7.

One Workgroup member suggested the removal of "for example" from the legal text. The Proposer and Workgroup agreed with this suggestion.

The Proposer made the Workgroup aware that <u>CMP316</u> is also proposing changes to CUSC 14.15.7.

The Proposer asked if a worked example should be included in the legal text. One Workgroup member suggested striving to keep the legal text as simple and clean as possible but asked if a guidance note on how the proposed change would work in practice could be provided instead. One Workgroup member suggested that CMP424 could be referenced in the legal text which would provide background to the change and clarity on how it works. One

Workgroup member noted that there is evidence in the CUSC that this has been done before. The Proposer agreed to consult with the ESO legal team on this matter.

Terms of Reference update
