1 Introductions and Apologies for Absence

13 STC Procedures

PM080: New STCP to cover the functional requirements of Active Network Management Schemes (AMNs)

3644. KD confirmed that some further feedback had been incorporated into the latest draft of the procedure (STCP26-1) and circulated with the papers. The Modification Panel confirmed their approval of the STCP and LH will arrange for formal sign off.

3645. KD confirmed that the final version of the ANM Guidance Note has also been circulated with the papers and will be published on the NG website once the STCP has been approved.

PM083: STCP19-5 Update and clarification of process for issuing an Final Section K Notification (FSKN) to prospective OFTOs

3646. ML advised that there is an issue regarding whether the proposed wording in the revised STCP accurately reflects the OTSDUW process. ML noted that as the relevant part of the process is

currently being gone through with Westermost Rough, this may help in establishing a way forward and some appropriate wording.

PM084: Improvements to Revenue Forecast Information Provision under STCP24-1

3647. At the June 2015 meeting, the Modification Panel approved the STCP for formal sign off, subject to formal approval being provided by ML from an OFTO perspective. LH confirmed that the draft had been forwarded to ML and that comments/approval are awaited.

14 European Developments

ENTSO-E update

3648. JL confirmed that the ENTSO-E update regarding the latest European developments had been circulated to the Modification Panel.

Joint European Stakeholder Group (JESG)

3649. DM advised that the last JESG took place on 10 July 2015, followed by HVDC and DCC stakeholder meetings on 14 and 16 July 2015 respectively.

TSO Issues

3650. There were no TSO issues.

15 Offshore Regime

3651. AS advised that an Offshore update from Ofgem had been circulated to the Modification Panel on 28 July 2015.

16 Code Administration Code of Practice (CACoP)

3652. LH confirmed that the final draft of Principle 13 of the CACoP had been circulated with papers for approval by the Modification Panel. The Panel provided their approval, subject to confirmation from SPT by 31 July 2015.

3653. LH advised that an Open Letter regarding the Annual review of the CACoP had also been circulated with papers and asked the Modification Panel for any comments prior to its issue at the end of July 2015. The Panel were happy for the letter to be published.

Joint Planning Committee

3655. The last JPC meeting was held in July 2015 and the minutes will be circulated to the Modification Panel once agreed.

Charging User Group

3656. The last ChUG meeting took place on 22 April 2015 and the minutes will be circulated to the Modification Panel once agreed.

19 Any Other Business

Confidentiality of information re OFTOs

3657. A concern has been raised via the JPC with respect to the arrangements in place for OFTOs to ensure confidentiality of information. JL confirmed that this was originally raised a number of years ago and is in relation to existing OFTOs having a competitive advantage over new OFTO entrants. JL proposed to close the action as it is now no longer relevant.

ITPR

- 3658. In respect of ITPR and the enhanced SO role, JL confirmed that Ofgem have requested a proposed timetable of STC/STCP changes. JL noted that although NGET is carrying out an initial review of impacts and developing a proposed timetable, it would be sensible to wait until the process has been gone through with a view to then making the changes in Spring 2016.
- 3659. KS queried whether this review would just be addressing ITPR changes or if it would also incorporate BAU changes. JL suggested that an annual rolling document review of all STC documents would be useful going forward. However, NGET will look at the ITPR impacts to understand the magnitude initially and then agree a way forward on those which are not impacted.
