1 Introductions and Apologies for Absence

3 Review of Actions

4015. Minute 3951: STCP19-3 Operational Notification and Compliance Testing

AT confirmed that NGET are currently reviewing this. AT advised panel that a red line version will be released this year and will be open to comments in December ahead of the modification being submitted in early 2017.

4016. Minute 3956: Schedule 9 TO Construction Terms

It was noted that the internal NGET SO lead is moving role with National Grid, AT stated that she will confirm the new point of contact at the next meeting.

4017. Minute 4000: Schedule of STC document reviews

AT advised the Panel that she had applied a RAG status on each area of the STC and the STCP procedures. She noted that the key on the document outlines the time elapsed since each area was last reviewed. The implications of ECIT and the requirement under it were discussed as AT highlighted that the majority of the STC and STCPs will be reviewed as part of ECIT. It was agreed that reviewing the STC and STCP would be put on hold until further information on ECIT was available.

4025. CM059-Dispute Resolution Process 'Changes to Section C and H following OFGEM Response to Adjudication Request'

RF requested confirmation on what element of the licence would support the efficient discharge of the obligations imposed upon transmission licensees by transmission licences and the Act. AT to send RF a reference regarding the licence. RF also asked for clarity on the applicability of who the disputes process applies to. It

was agreed that the two questions need to be answered and that the modification needed to be updated and re submitted to the November Panel meeting to be approved to proceed to Industry Consultation.

4032. Joint European Stakeholder Forum (JESG)

She explained that a number of other 'EID light' options were also discussed. The next JESG meeting will take place on 23rd November 2016, CB invited attendance from the Panel to hear more on the proposals and feed in their views on the proposed options.
