# Charging User Group Meeting Minutes 3<sup>rd</sup> September 2014

- Under CUSC, TOs are obliged to publish quarterly STCP24-1 updates
- Revised submission dates were agreed as follows:

April – year ahead forecast

July – year ahead forecast

October – 5 year forecast

January – 5 year forecast

- SB to update the STCP24-1 document to take account of the revised submission dates (in diagram format), new template format & update to section 1. A draft will be circulated to ChUG members by 3<sup>rd</sup> October for review (Action CH057)
- SB confirmed that NGET will collect the 15/16 Distribution Network Innovation Competition Fund. As this will require a Licence Condition change, DS to confirm if Ofgem have addressed this (Action CH058)
- Review of slides to be presented at the 2015/16 TNUoS Tariffs webinar on 05/09/14:
  - Proposal to reduce the amount of revenue to be recovered from generation customers from 27% to 23% to ensure continued compliance with EU regulation. Assumption is that regulation will be changed from next year
  - Forecast peak demand has fallen by approx 1.1GW
  - Generation has fallen by 1.5GW between May and July

# 7. TCMF Update

- Section presented by Andrew Wainwright concerning TNUoS charging arrangements for exporting GSPs
- Different charging options were proposed and there may be a CUSC modification as a result of further discussion.
- Update on progress will be provided at the September TCMF

- SS provided ChUG members with a copy of the NGET charge setting timetable
