#### CMP 219 - Recap

- CMP219 is a 'tidy-up' modification to refine the legal text introduced by CMP192 into the CUSC
- Minor corrections and clarifications to deal with drafting errors
- Reflects the original intent of CMP192 workgroup report and proposes nothing new
- Refine CMP192 legal text prior to further development of CUSC Section 15 for offshore and non-generation users

#### **Progress**

- The first workgroup meeting was held on 18 June 2013
- Consensus on changes to the legal text in the CMP219 modification proposal
- 4 weeks consultation period ended on 6 August 2013
- 3 official responses along with comments from CMP219 workgroup members

#### Responses

- In line with the intent of CMP219
  - Clarifications and corrections
- Out of scope of CMP219
  - Arrangements for generation users connecting into distribution networks

## **Workgroup Vote**

- Vote 1: whether Original and any WACMs better facilitates the Applicable CUSC Objectives;
- Vote 2: Whether each WACM better facilitates the Applicable CUSC Objectives than the Original Modification Proposal;
- Vote 3: which option is considered to BEST facilitate achievement of the Applicable CUSC Objectives. For the avoidance of doubt, this vote should include the existing CUSC baseline as an option.

## **Applicable CUSC Objectives**

- a) The efficient discharge by the licensee of the obligations imposed upon it under the Act and by this licence;
- b) Facilitating effective competition in the generation and supply of electricity, and (so far as consistent therewith) facilitating such competition in the sale, distribution and purchase of electricity;
- c) Compliance with the Electricity Regulation and any relevant legally binding decision of the European Commission and/or the Agency.
