

1 Summary

- 1.1 This document describes the CMP257 CUSC Modification Proposal and contains responses from the Code Administrator Consultation and CUSC Panel decision to implement the modification.
- 1.2 CMP257 was proposed by National Grid Electricity Transmission and submitted to the CUSC Modifications Panel for their consideration on 27th November 2015. A copy of this Proposal is provided in Annex 1. The Panel decided that this Modification should be classed as Self-Governance and should proceed directly to Code Administrator Consultation for 20 Working-Days.
- 1.3 CMP257 seeks to allow for the electronic issue of offers and other formal documents (where agreed) and removes the obligation to provide hard copies of documentation once elected.
- 1.4 This Draft CUSC Modification Report has been prepared in accordance with the terms of the CUSC. An electronic copy can be found on the National Grid Website, <u>http://www2.nationalgrid.com/UK/Industry-information/Electricity-</u> codes/CUSC/Modifications/CMP257/, along with the CUSC Modification Proposal Form.

National Grid's Initial view

1.5 National Grid believes CMP257 should be implemented as it better facilitates Applicable CUSC Objective (a) by improving the efficiency of the application process.

CUSC Panel recommendation

1.6 At the CUSC Modifications Panel meeting on 18th March 2016 the Panel voted by unanimously agreed that CMP257 better facilitates Applicable CUSC Objective (a) as it increases efficiency and therefore should be implemented.

2 Defect

- 2.1 Currently the CUSC does not allow for the electronic (email) issue of 'Offers' e.g. Connection Offers or Use of System Offers, or other formal documents. It requires National Grid (amongst the other options under CUSC Section 6.21) to print and post hard copies of these documents to send to customers even if the customers have requested electronic copies of their documents, therefore creating unnecessary administration and time costs.
- 2.2 If the CUSC allowed for electronic issue of these documents and the customer to 'opt out' of receiving hard copies of documentation, this would reduce these unnecessary administration and time costs creating a more efficient process.

3 Modification Proposal

- 3.1 CMP257 seeks to make several changes to the CUSC to allow for the electronic issue of 'offers' and other formal documents (where agreed by the customer) and removes the obligation to provide hard copies of documentation once elected.
- 3.2 This modification would provide an additional option for customers to choose the format in which they receive their 'Offers' from National Grid (and other documentation as and where agreed) and would make the process of providing 'Offers' more efficient.

4 **Proposed Implementation and Transition**

4.1 It is proposed that CMP257 (if approved by the CUSC Panel) should be implemented one Working day following closure of the fifteen Working Day appeals window (if no successful appeals are received).

6.2 National Grid believes CMP257 should be implemented as it better facilitates Applicable CUSC Objective (a) by improving the efficiency of the application process.

7 Code Administrator Consultation Responses

7.1 The CMP257 Code Administrator Consultation closed on 8th January 2016 and received three responses. These are summarised below and are provided in full in Annex 3.

E.ON and Uniper	Yes. For the reasons given in the consultation	Yes.	We would encourage National Grid to consider whether further future changes are required for other documents such as LDTEC and STTEC offers. We would welcome flexibility for documents other than Offers to be provided electronically where both parties agree.
RWE	No. We do not agree with the Draft Legal text 6.21.3 that "electronic communicationsshall be deemed to have been received 10 minutes after it has been sent". Given the vagaries or email reliability and delivery, we believe this unreasonable. We believe positive confirmation of receipt from the intended recipient. Without this safeguard in place, CUSC parties may be reluctant to agree to Offers being provided only by electronic means. We believe that if CMP257 incorporated this requirement it would better facilitate the CUSC objectives. We also belive that CMP257 is too narrow in scope as it only applies to Offers issued by National Grid.	Subject to our other comments, we support the implementation approach.	We would suggest that CMP257 also applies to the submission of a CUSC Application by a CUSC Party to National Grid. We would suggest that the Legal text provides for more than one email address to be provided. We believe it would be useful for CMP257 to be extended to other CUSC documents, in particular LDTEC and STTEC.
Scottish Power	Yes. Better facilitates objective (a) as it improves the efficiency of the connection process.	Yes.	We support the use of electronic communication and think it should be adopted as far as practicable for communication under the CUSC. Use of electronic communication should always be subject to prior agreement between parties. We would be interested to know how National Grid would record Parties' formal agreement and where this information would be stored.

CUSC Panel Recommendation Vote

8.1 At the CUSC Modifications Panel meeting on 18th March 2016, the Panel voted on CMP257 where they unanimously agreed that CMP257 better facilitates Applicable CUSC Objective (a) as it increases efficiency and therefore should be implemented. Garth Graham was absent for the vote and gave his voting rights to James Anderson, Simon Lord was also absent for the vote and gave his voting rights to Paul Jones. Nikki Jamieson was also absent and gave her voting rights to Andrew Wainwright.

Description of the Issue or Defect that the CUSC Modification Proposal seeks to address

In its current form CUSC does not allow for the electronic (email) issue of 'offers' e.g. Connection Offers or Use of System Offers, or other formal documents, as an acceptable form of issue and in practice this results in 'offers' being printed and posted, even where provided to customers electronically in parallel and/or where not requested. Therefore the defect is a more limited choice of 'offer' provision than could be available for customers and in some cases an unnecessary administrative burden on National Grid.

Description of the CUSC Modification Proposal

This proposal aims to make a handful of changes to CUSC (as per the draft legal text below) to allow for the electronic issue of 'offers' and other formal documents (where agreed) and removes the obligation to provide hard copies of documentation once elected. The proposed change would result in an additional option for customers to choose the format by which they receive 'offers' and could save National Grid wasted administration cost and time by removing the obligation to provide a hard copy of documentation where not required by the customer.

This is the CUSC Modifications Panel's Self-governance Statement to the Authority for CUSC Modification Proposal (CMP) 257. National Grid has prepared this Self-governance Statement on behalf of the CUSC Modifications Panel and submits it to you in accordance with CUSC Section 8.25.1.

On 27th November 2015 the CUSC Modifications Panel considered CMP257 and confirmed unanimously that it meets the Self-governance criteria.

As such, CMP257 is unlikely to discriminate between different classes of CUSC Parties and is unlikely to have a material effect on:

- i) Existing or future electricity customers;
- ii) Competition in the generation, distribution, or supply of electricity or any commercial activities connected with the generation, distribution or supply of electricity,
- iii) The operation of the National Electricity Transmission System
- iv) Matters relating to sustainable development, safety or security of supply, or the management of market or network emergencies
- v) The CUSC's governance procedures or the CUSC's modification procedures

Q	Question	Response
1	Do you believe that CMP257 better facilitates the Applicable CUSC objectives? Please include your reasoning.	 No. We do not believe that CMP257 as proposed better facilitates the CUSC objectives for the following reason: We do not agree with the Draft Legal text 6.21.3 that <i>"electronic communicationsshall be deemed to have been received 10 minutes after it has been sent"</i> Given the vagaries of email reliability and delivery, we believe it unreasonable and inefficient for such an assumption to be made. We would suggest that such legal communications should only be deemed to have been received by the recipient after the sender has received positive confirmation of receipt from the intended recipient. This could be achieved simply by a non-automated acknowledgement sent via email from the recipient to the original sender which would then start the 90-day validity period clock. In any event, such acknowledgement would mirror the delivery receipt provided when paper Offers are issued via special delivery. Without this safeguard in place, CUSC Parties may be reluctant to agree to Offers being provided only by electronic means. We believe that if CMP257 / CUSC 6.21.3 incorporated the above requirement it would better facilitate the CUSC objectives. Further, whilst not necessarily a clear reason for not meeting the CUSC objectives, we believe that CMP257 is too narrow in scope, in that it only applies to Offers issued by National Grid (see comments under Q4) and fails to provide for similar benefits that might be achieved by other CUSC Parties.
2	Do you support the proposed implementation approach? If not, please provide reasoning why.	Subject to our comments under Q1, we support the proposed implementation approach.
3	Do you have any other comments?	(i) We would suggest that the CMP257 also applies to the submission of a CUSC Application by a CUSC Party to National Grid. Indeed, we would have expected this provision to have been included in the proposal that covers the issue of the resulting Offer by National Grid to the CUSC Party.

		(ii) Regarding the Draft Legal Text, we suggest that the form provides for more than one email address to be provided if required.
4	documents other than Offers (under the Exhibits listed in Section 5.1 of this consultation) to be provided electronically where both parties agree	We believe it would be useful for the proposed amendment to also be extended to other CUSC documents, in particular the requirement under CUCC 6.31 to arrange LDTEC and STTEC via fax. In the case of LDTEC and STTEC, the CUSC requirement to use fax communications appears to prohibit the parties agreeing to other electronic forms of communication. We therefore suggest that the legal text of CUSC 6.31 also be amended to similarly enable the use of electronic communications.

Edit paragraph 11 of Exhibit C, paragraph 6 of Exhibits E and G and R, paragraph 4 of Exhibit H and paragraph 8 of Exhibit J by adding after the word "sign" "(and where issued by email, having printed off 2 copies of each)".

- 3. Add the following as new paragraphs 6.21.3 through 6.21.5 in CUSC Section 6 and renumber the existing paragraph 6.21.3 as 6.21.6 to reflect the insertion.
 - "6.21.3 Where **CUSC** expressly provides for notices or other communication to be by electronic means or a **CUSC Party** otherwise agrees this with another **CUSC Party**, the electronic communication shall be addressed and sent to the address provided for this purpose and shall, subject to Paragraph 6.21.4, be deemed to have been received one hour after it has been sent in the absence of an undeliverable return receipt received by the sender during that period.
 - 6.21.4 If the time at which any notice or communication sent by e-mail is deemed to have been received falls after 17.00 hours on a day, the notice or communication shall be deemed to have been received at the start of the next **Business Day**.
 - 6.21.5 Where a notice or communication is sent by e-mail, the **CUSC Party** giving the notice or communication shall (but without prejudice to Paragraph 6.21.3), if requested by the recipient **CUSC Party** resend, as soon as reasonably practicable, the notice or communication by e-mail."
