Part 1 – Introduction

- This Glossary of Terms and Rules of Interpretation shall apply to each document published or to be published by NGESO which states (howsoever expressed) that it is governed by or subject to this Glossary of Terms and Rules of Interpretation (in this document, a "Related Balancing Services Document").
- 2. Any capitalised term used in this **Glossary of Terms and Rules of Interpretation** shall have the meaning given to it (if any) in Parts 3 or 4 below,
- 3. NGESO may update this Glossary of Terms and Rules of Interpretation from time to time by publication of the changes on its website which shall take effect from such time and date as may be specified by NGESO, save that unless otherwise required by Law no such changes shall apply to any extant Balancing Services Contract whose term shall not have expired by such time and date.
- 4. When publishing changes to this **Glossary of Terms and Rules of Interpretation**, **NGESO** may also publish a consolidated version of changes made to these this **Glossary of Terms and Rules of Interpretation**, but the consolidated version will not be a formal document and may not be relied upon in any way.

Part 2 – Rules of Interpretation

- Unless the context otherwise requires or expressly provided otherwise, all references in a Related Balancing Services Document to a particular paragraph or Schedule shall be a reference to that paragraph or Schedule in or to that Related Balancing Services Document.
- A table of contents and headings inserted in this Glossary of Terms and Rules of Interpretation and any Related Balancing Services Document is there for convenience only and shall be ignored in construing their terms.
- 3. In this **Glossary of Terms and Rules of Interpretation** and the **Related Balancing Services Documents** all and any references to the words "include" or "including" are to be construed without limitation to the generality of the preceding words.
- 4. Unless the context otherwise requires, any reference in this **Glossary of Terms and Rules of Interpretation** or a **Related Balancing Services Document** to an Act of Parliament or any part or section or other provision of or section to an Act of Parliament shall be construed, at the particular time, as including a reference to any modification, extension or re-enactment thereof then in force and to all instruments, order or regulations then in force and made under or deriving validity from the relevant Act of Parliament.
- 5. All references in this **Glossary of Terms and Rules of Interpretation** and the **Related Balancing Services Document** to the masculine shall include the feminine and references in the singular shall include the plural and vice versa and words denoting persons shall include any individual, partnership, firm, company, corporation, joint venture, trust, association, organisation or other entity, in each case whether or not having separate legal personality.
